Thank you for choosing Larry Wilner, D.O. And Paige Corbett, NP as your health care providers. We are committed to providing the best and the most favorable treatment for our patients. Our charges reflect what is usual and customary for our area. You are responsible for payment regardless of any insurance company's arbitrary determination of usual and customary rates. Please understand that payment of your bill is considered part of your treatment. The following is statement of our financial policy, which we require you to read and sign prior to any treatment.

All patients must complete our information and insurance form before seeing the doctor.

- CO-PAYMENTS ARE DUE AT THE TIME OF SERVICE. IF YOU CANNOT PAY YOUR COPAY AT TIME OF SERVICE YOU WILL NEED TO RE-SCHEDULE YOUR APPOINTMENT.
- WE ACCEPT CASH, CHECKS, VISA, MASTERCARD, DISCOVER, OR AMERICAN EXPRESS.
- RETURNED CHECKS WILL BE ASSESSED A \$20.00 RETURNED CHECK FEE AND THE
- PATIENTS ACCOUNT MAY BE SUBJECT TO REFUSAL OR FUTURE ACCEPTANCE OF CHECKS AS PAYMENT.
- WE ARE NOW REQUIRING 24 HOURS CANCELLATION OF APPOINTMENTS. FAILURE TO DO SO WILL RESULT IN A \$25.00 CHARGE TO THE PATIENT.
- "NO SHOW" APPOINTMENTS WILL BE AUTOMATICALLY ASSESSED A \$25.00 FEE. PATIENTS THAT ARE 15 MINUTES OR MORE LATE FOR THEIR APPOINTMENT WILL NEED TO RESCHEDULE.

REGARDING INSURANCE

We will bill your insurance as a courtesy. We cannot bill your insurance unless you give us your current insurance information. You are responsible for any co-payments or co-insurance, plus any balance due on non-covered services from your plan. Your insurance is a contract between you and your insurance company. We are not a party to that contract. It is your responsibility to understand your policy and know what benefits you hold. Please be aware that some, and perhaps all, of the services provided may be non-covered by your medical insurance, in which case you would be responsible for the charges for those services.

For insurance plans where Larry Wilner, D.O. And Paige Corbett, NP are participating providers and which require a co-payment, all co-payments are due before service is rendered. In the event that your insurance coverage changes to a plan for which we are not participating providers, refer to the above paragraph.

MINOR PATIENTS

The adult accompanying a minor, or the parent(s) (or guardian(s) of the minor) is responsible for the payment before the service is rendered.

A divorce decree does not determine which party Larry Wilner, D.O. And Paige Corbett, NP will bill for medical services. Divorce decrees are only binding upon the two parties who made the agreement. The parent accompanying the child(ren) on the first appointment will be considered the guarantor on the patient's account. The guarantor is responsible for co-payments before the service is rendered. For unaccompanied minors, non-emergency treatment will be denied unless services have been consented to by the responsible party or guardian.
